I understand and agree that Aquaventure Dive & Photo Center makes no guaranty, representation or warranty including any implied warranty of merchantability or fitness for particular purpose with respect to the diving equipment serviced.

I hereby state I carefully reviewed this Service Agreement, and I acknowledge, recognize, appreciate, and assume all risks inherent in the sport of scuba diving and in the use of scuba diving equipment and waive each and every claim for injuries, damages and losses, including claims for negligence, which I may have against Aquaventure Dive & Photo Center and its employees, instructors, agents, and representatives, arising out of services performed or not performed under this Service Agreement.
